Ian Powys is a descendant of Sir Thomas Powys with transcripts of original documents

Notes

- 1. The above is an adequately documented proof from public records of lan's paternal line descent from Sir Thomas.
- 2. Copies of the supporting birth and marriage documents accompany this report.
- 3. A similar proof with documents has been provided for Tim Powys-Lybbe for his paternal line descent from Sir Thomas. Similarly for William Powys when he has been proven by the Big-Y test to be another descendant of Sir Thomas.
- 4. These lines of descent have been known for each person publicly from the day of their baptism or birth and no challenge has ever been made of the validity of these historical lines.
- 5. We can safely declare that the nearest common ancestor of lan and Tim is, from original historical documents, Sir Thomas.
- 6. Both Ian and Tim have been tested by Family Tree DNA for their Y-DNA and both have the same Y-DNA. This Y-DNA is measured from a Single Nucleotide Polymorphism, SNP pronounced 'Snip' and named R-FT287223. So they must have a DNA-proven common ancestor who is known historically, above, to be Sir Thomas.
- 7. This means that their first shared male-line ancestor, Sir Thomas, must be the source of this SNP and must have carried it as well.
- 8. This means that all their male-line ancestors back to Sir Thomas and his male-line ancestors have the same SNP. If Sir Thomas' supposed male line ancestors do not have this SNP, they are not his ancestors.
- 9. It also means that all male-line descendants of all these ancestors also have this SNP. If they don't, this means they are not descendants.
- 10. If anyone else is found to have this SNP, they have to be related to these Powyses and share a common ancestor. It is convenient to refer to this SNP as the Powys SNP.
- 11. The way to find the SNP of a deceased person is to find two separate male lines of descendants and then test them for their SNP values carried by living males of each line. Sir Thomas had five sons of which only two had any descendants at all and in fact have between them around 22 male line descendants living today.
- 12. The reason for testing relatives who were so distant is that it means that their common ancestor will be that more distant in time and thus have more generations and more descendants to be included in any SNP that was found.
- 13. So far about 2040 descendants of Sir Thomas have been found, 180 of whom are males in male lines and of these about 22 are alive now and should bear the Powys SNP. One wonders how many do?
- 14. There are two possible lines of illegitimate descent that may descend from the youngest son John of William of Ludlow. If we could find descendants of either line and beg them to take the Y-DNA test and they had the Powys DNA, this would extend it back to the common ancestor, William of Ludlow, and bring in several other branches as probable carriers of the Powys SNP.
- 15. A chart is available on my website at <powys.org/DNA> that shows all the males of male-only descent whose lines lasted more than a few generations from Sir Thomas. Hopefully this also shows all the living such male-line descendants who should all have the Powys SNP.
